Public Hearing – *Local Law No. 1 of 2019, Amending Local Law No. 2 of 1986 Authorizing the Conduct of Games of Chance in the Town of Murray*

This proposed local law was introduced at last month's meeting. It amends the Local Law of 1986; anyone applying for a game of chance license must undergo fingerprinting and a background check.

Motion by Hendel, Seconded by Mele adopting Town of Murray Local Law No. 1 of 2019 – *Amending Local Law No. 2 of 1986 Authorizing the Conduct of Games of Chance in the Town of Murray* Motion Carried

New Business

Brief discussion regarding proposed Local Law No. 2 of 2019 – *Amending the Town of Murray Zoning Ordinance to Establish a Senior Housing District for Individuals 55 Years of Age and Older*. The Town Planning Board held a meeting a couple of weeks ago and decided to refer it to our own Town Board for their consideration. If the Town Board is inclined to introduce it tonight, a public hearing can be scheduled. This would also have to be sent to the County Planning Board.

Motion by Christ, Seconded by Hendel introducing Local Law No. 2 of 2019 – *Amending the Town of Murray Zoning Ordinance to Establish a Senior Housing District for Individuals 55 Years of Age and Older* and to forward the proposed Local Law to the County Planning Board Motion Carried

Brief discussion regarding proposed Local Law No. 3 of 2019 – *A Local Law to Override the Tax Levy Limit Established in the General Municipal Law Section 3-c*. New York State limits the amount of increase that a town can adopt to 2% or the rate of inflation, whichever is less. As a precautionary measure, the Board puts this local law in place in the event that the Town goes over the limit but we do not anticipate exceeding the limit. If the Town stays below the 2% then the local law will be null and void.

Motion by Christ, Seconded by Valentine introducing Local Law No. 3 of 2019 – *A Local Law to Override the Tax Levy Limit Established in the General Municipal Law Section 3-c*. Motion Carried

Public Hearings on the tentative water assessments, preliminary budget and the tax cap law will be held on October 29th at 7:00 p.m.
